

**ORDINANCE NO. 2010 - 17**

**ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, MODIFYING AND AMENDING THE CODIFIED ORDINANCES OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, IN PARTICULAR CHAPTER 71 ENTITLED "VEHICLES AND TRAFFIC"**

**BE IT ORDAINED** by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, that Chapter 71 of the Township Code entitled "Vehicles and Traffic" is hereby modified to include new Article XII entitled "Traffic Patterns for Railroad Avenue Between West Bay Avenue and Burr Street", as follows:

**SECTION 1. Article XII – Traffic Patterns for Railroad Avenue Between West Bay Avenue and Burr Street**

- A. Railroad Avenue is a divided roadway which extends to the north from West Bay Avenue to the Burr Street. The westerly side of Railroad Avenue extends in a straight line from West Bay Avenue to Burr Street while the easterly side of Railroad Avenue extends to the north for a distance of approximately 300 ft. at which point it turns to the west and forms a 3-way intersection with the westerly side of Railroad Avenue. One-way traffic in a northbound direction shall be permitted on the easterly side of Railroad Avenue. On the westerly side of Railroad Avenue, two-way traffic shall be permitted between Burr Street and the intersection with the easterly side of Railroad Avenue. From that 3-way intersection of the westerly side of Railroad Avenue with the easterly side of Railroad Avenue to the intersection with West Bay Avenue, one-way traffic in a southbound direction shall be permitted.

**SECTION 2.** The Township shall post appropriate signage in order to properly implement this change in the traffic pattern, and properly advise the public of this traffic pattern change.

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.
