

**RESOLUTION 2017-197A**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY APPOINTING STACEY COLE TO THE POSITION OF PLANNING/ZONING ADMINISTRATOR OF THE TOWNSHIP OF BARNEGAT**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has reestablished the position of Planning/Zoning Administrator; and

**WHEREAS**, Stacey Cole, a long time employee of the Township, has been employed as the Planning Board Secretary and has taken over the functions of the Planning/Zoning Administrator of the Township, notwithstanding the fact that she was not formally appointed to that position or paid in accordance with the salary requirements of that position; and

**WHEREAS**, the Township believes it appropriate and necessary to appoint Stacey Cole to the position of Planning/Zoning Administrator of the Township; and

**WHEREAS**, the appointment of Stacey Cole to that position is in accordance with the Township's budgetary constraints.

**NOW, THEREFORE, BE IT RESOLVED**, this 2nd day of May 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby appoints Stacey Cole to the position of Planning/Zoning Administrator of the Township, effectively immediately.
2. Stacey Cole shall no longer be employed by the Township as the Administrative Assistant of the Planning/Zoning Administrator.
