

**RESOLUTION 2017-87**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING A SALE OF TWO MOTORCYCLES TO THE TOWNSHIP OF BRICK FOR AND IN CONSIDERATION OF \$39,000.00**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has been advised by representatives of the Barnegat Township Police Department (hereinafter referred to as the "Police Department") that the Township is no longer in need of two motorcycles previously operated by the Township and the Police Department; and

**WHEREAS**, representatives of the Police Department have found a purchaser for the two motorcycles, the Township of Brick and the Brick Township Police Department; and

**WHEREAS**, the Police have reached an agreed upon purchase price of \$39,000.00 for the two vehicles; and

**WHEREAS**, the motorcycles have the following Identification Numbers:

1HD1FMM11GB631396 (2016 HD FLH)

**WHEREAS**, the Township, in accordance with the provisions of N.J.S.A. 40A:12-13 et seq, believes it appropriate and necessary to sell to another public entity property no longer needed; and

**WHEREAS**, the Township believes that the purchase price of \$39,000.00 for the two motorcycles is appropriate, fair and reasonable.
