RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A REDUCTION OF THE PERFORMANCE GUARANTEE FOR THE WATER SYSTEM IMPROVEMENTS FOR OCEAN ACRES, PHASE 9

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a request for a reduction in the performance guarantees for the water system improvements for Ocean Acres, Phase 9 (hereinafter referred to as the "project"); and

**WHEREAS**, for the reasons set forth in the aforementioned review letter, Mr. Hess has recommended that the performance guarantees be reduced to thirty (30%) percent, as follows:
