

**RESOLUTION NO. 2019 – 128**

**RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RELEASE OF A MONUMENT BOND FOR SECTIONS 3B AND 3C OF HERITAGE POINT NORTH.**

**WHEREAS**, The Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, (the “Township”), has received correspondence dated January 22, 2019 from WSB Engineering Group, P.A., the engineer for the applicant, Mignatti Companies, requesting release of the Monument Bonds for Section 3B and 3C of the Heritage Point North development; and
