

**RESOLUTION 2019 – 149**

**A RESOLUTION AUTHORIZING THE PURCHASE OF AUTOMOTIVE PARTS, SUPPLIES AND REPAIRS FOR VEHICLES UNDER THE STAFFORD TOWNSHIP COOPERATIVE PRICING SYSTEM CONTRACT ID #33-OCCPS-2019-003**

**WHEREAS**, the Township of Barnegat is a member of the Ocean County Cooperative Pricing System in which Stafford Township is the Lead Agency; and

**WHEREAS**, the Township has submitted for participation in the Co-p bidding process for the purchase of automotive parts, supplies and repairs; and

**WHEREAS**, Stafford Township as the Lead Agency in the Ocean County Cooperative Pricing System has awarded a twenty-four (24) month contract (April 4, 2019 through April 3, 2021) excluding repairs, for automotive parts, supplies and repairs for vehicles under 15,000 GVWR; and automotive parts, supplies and repairs for vehicles 15,000 GVWR and greater for the Stafford Township Cooperative Pricing System (ID #33-OCCPS-2019-003) and its members in accordance with the discount percentages for automotive parts and supplies (excluding repairs) as listed on the attached schedules to the following listed vendors:

**WHEREAS** the Township of Barnegat does hereby award a contract to the above Contractors for the purchase of Automotive Parts, Supplies and Repairs for vehicles in accordance with the bid specifications as written and the bid proposals as submitted; and

**WHEREAS** this contract shall be an open-ended contract with funds being encumbered contingent upon the availability of funds in the budget year. The Township of Barnegat, under this contract, is only obligated to purchase automotive parts and supplies (excluding repairs) from the Contractors on an as need basis, and each order is subject to the availability of funds.

**WHEREAS** this contract does not impose upon the Township of Barnegat an obligation to purchases any specific quantity of automotive parts, supplies or repairs. This contract does set the price for the quantity of automotive parts, supplies and hourly rate for repairs for which the Township may purchase from the Contractors.

**WHEREAS** No purchases shall be made under this contract until the Chief Financial Officer ("CFO") has certified the availability of funds for such purchases to the following:
