Committee Reports: Bille, Pipi, Townsend, Cirulli

**Al Bille:** Spoke about how the Food Pantry is doing great! Looking to remove the trailer and replace it with a shed, with the help of DPW. Fire Wise meeting at Pinewood and was asked to install deer signs in the area of Brighton and Pinewood. There is a lot of paving going on and Kurt can give update.

Recreation report – Concerts coming up on June 15<sup>th</sup> and every Saturday night. Family Fun Night at the recreation center on Tuesday's and Thursday's. Sign up on website. Thanked DPW for maintaining the beach. Fireworks on July 5<sup>th</sup>. Last year had 3,000 people.

**Pat Pipi:** Mentioned that DPW did a great job cleaning up the docks on June 15<sup>th</sup>. Code Report for May – There were 23 rental inspections, 6 re-inspections, 41 letter of no interest, 97 zoning permits and 152 warning stickers were issued.

**Jake Townsend:** Gave water report for the month of May. Total work order for the year is 652. Hydrant flushing is completed.

Al Cirulli: Thanked everyone who participated in Adopt-A-Street. They did a fantastic job! Fire Report – Had 33 incidents in the month of May. On May 25th there was a structure fire on 94 Village Dr. No injuries! Total calls for the year is 211. First Aid Report – Quality answered 100% of calls. Barnegat First Aid is back up and answered 48 calls in May. Barnegat is well covered.

<u>Mayor's Report:</u> Police Report – Answered 1477 calls, responded to 223 medical emergencies, 52 MVA and 95 summons were issued. Crime Reduction Unit made 9 arrest. Mentioned few new businesses that opened in town. Joe Canal's Liquor store at Barnegat 67 and Pick It Plus on W. Bay. Possible UPS Store in Acme shopping center. Thanked businesses for helping with fundraiser for our Barnegat PBA.

**Kurt Otto:** Gave summary of paving projects. Recently paved Pine Oak Blvd, Spruce Circle N & S, Fairway Drive and Avast Ave. Pennsylvania Ave. is under design. Next is First St. County paved Nautilus to W. Bay and Gunning River. Lighthouse is scheduled for bid this year. Bay Shore Dr. is under preliminary design.

**Maria Acevedo:** 134 Redwood Dr. – Thanked everyone for coming to our Fire Wise meeting.

**Ronald Napes:** 153 Brighton Rd. – June is LGBQT Pride month. New organization called Barnegat Pride. June 22<sup>nd</sup> will be the 1<sup>st</sup> Pride Celebration. Rent Leveling Law - \$5,000 capital feels it's grossly too low. Need amendment to raise to \$50,000. Time of the essence. Had many conversations, no feedback or input!

Chris Dasti answered Ron that Pinewood was supposed to get information to him. We need documentation to support a number. Made myself available to Pinewood. Need tools to support the amendment.

Ron said that there is a mass confusion for meeting. Brighton is \$100,000. Mr. Cirulli mentioned that number has to be raised and is willing to get meeting together.

**Dianne Grockenberg:** 108 Redwood Dr. - Brought information of what Pinewood has been charging. Pictures of septic system. Has testimony on phone from previous maintenance manager. Electrical board are also a problem. Agreed with Al Bille about the food bank and the people are wonderful! Spoke about Starve Poverty. Ordinance 2024-14 – Had question about trees and shrubs, are we exempt? Chris Dasti answered that it's a state wide NJDEP ordinance.

**Lorraine Ferraro:** 121 Cypress Ln. - Agreed with Dianne on food pantry. Spoke about rent leveling. Mr. Naples brought up the \$5,000 was under the budget back in the beginning. Chris Dasti re-iterated he needs documentation. We agree \$5,000 is low. It's for everyone's benefit to have the break down to support the increase. Thought Pinewood was going to get information.

Lorraine – Don't recall to get documentation. Inflation alone should be enough to raise the amount. Any time frame? Al Cirulli said next meeting.

**Genevieve Rubenstein:** 4 Hickory Circle – Thanked the Police and First Aid for the quick response. Saved my husband who is in the hospital. So blessed with the superior Police Dept. Officer Duncan was amazing for calming the situation.

**Dave Kristick:** 186 Chestnut Way – Mr. Dasti is correct. At the March meeting documentations would be provided for the increase. Documentation was supposed to be submitted by June no later than July. The state worked 100% with you. I have nothing to do with the rent leveling agreement. Thank you all for all you do! Yes, we have to supply information!

**Frank Belluardo:** 196 Chestnut Way - We need changes in this amendment and we were not involved. We have a problem with AC Electric. They are not helping us be safe. We are trying to help ourselves but we need assistance.

Al Cirulli mentioned that the main reason was to get it back on the books.

Frank asked if the RHP is doing any electric repairs? In 2023 11 units were replaced. Now we still have 22 units needing service.

Al Cirulli said to notify us right away for safety. We will follow up with County and State. Frank mentioned that last year we had 2 septic problems now we have 3 more. People could not even go to a campground.
